## **ANNOUNCEMENT**

### Suspension of trading of the titles of companies listed on the Regulated Market continued

The Cyprus Stock Exchange announces the continuation of the suspension of trading of the titles of the following companies, further to a decision of the Securities and Exchange Commission taken by virtue of the power conferred on it by Article 70(2)(m) of the Investment Services and Activities and Regulated Markets Law of 2017:

- 1. Ishis Investment Public Ltd
- 2. Regallia Holdings & Investments Public Ltd
- 3. Aiantas Investment Public Ltd
- 4. Cyprus Trading Corporation Plc
- 5. Ermes Department Stores Plc
- 6. Woolworth (Cyprus) Properties Plc

Having taken into consideration the positions/announcements of the above companies and the fact that the Stock Exchange has no power to suspend their titles for an additional period of time, the Securities and Exchange Commission decided to request the CSE Council to suspend the trading of the titles of these companies listed on the CSE from 1<sup>st</sup> March 2023 until their compliance or until 28<sup>th</sup> April 2023 at the latest if, by the end of the current suspension period, they fail to comply with their obligation to publish their pending financial information.

The Commission reached the decision based on the following:

### (i) Ishis Investment Public Ltd and Regallia Holdings & Investments Public Ltd

The above companies have not complied with their obligation to publish:

- (a) their Half-Yearly Financial Report for the period ended 30/6/2020,
- (b) their Half-Yearly Financial Report for the period period 30/06/2021,

(c) their Half-Yearly Financial Report for the period ended 30/6/2022.

As a result, investors are not provided with the necessary information on the financial situation of these companies.

### (ii) Aiantas Investment Public Ltd

The above company has not complied with its obligation to publish:

- (a) its Annual Financial Report for the year ended 31/12/2019,
- (b) its Half-Yearly Financial Report for the period ended 30/6/2020,
- (c) its Annual Financial Report for the year ended 31/12/2020
- (d) its Half-Yearly Financial Report for the period ended 30/06/2021
- (e) its Annual Financial Report for the year ended 31/12/2021
- (f) its Half-Yearly Financial Report for the period ended 30/06/2022.

As a result, investors are not provided with the necessary information on the company's financial situation.

# (iii) Cyprus Trading Corporation Plc, Ermes Department Stores Plc, Woolworth (Cyprus) Properties Plc

The above companies have not complied with their obligation to publish:

- (a) their Half-Yearly Financial Report for the period ended 30/6/2021
- (b) their Annual Financial Report for the year ended 31/12/2021
- (b) their Half-Yearly Financial Report for the period ended 30/06/2022.

As a result, investors are not provided with the necessary information on the financial situation of these companies.
