**Suspension of trading of the titles of companies listed on the  
Regulated Market continued**

The Cyprus Stock Exchange announces the continuation of the suspension of trading of the titles of the following companies, further to a decision of the Securities and Exchange Commission, taken pursuant to the power conferred on it by article 70(2)(m) of the Investment Services and Activities and Regulated Markets Law of 2017, as applicable from time to time:

1. Isxis Investment Public Ltd
2. Regallia Holdings & Investments Public Ltd
3. Aiantas Investment Public Ltd
4. Cyprus Trading Corporation Plc
5. Ermes Department Stores Plc
6. Woolworth (Cyprus) Properties Plc

Having taken into consideration the positions of the above companies as well as the fact that the Stock Exchange has no authority to suspend the trading of the titles of the above companies for an additional period of time, the Securities and Exchange Commission decided to request the CSE Council to suspend the trading of the titles of these companies on the CSE from 2 January 2023 (first business day after the end of the suspension of trading of their shares) until their compliance, and by 28 February 2023 at the latest if, by the end of the current period of suspension they have not complied with their obligation to publish the pending financial information.

The Commission reached the above decision on the following grounds:

1. Isxis Investment Public Ltd, Regallia Holdings & Investments Public Ltd, Aiantas Investment Public Ltd

The above companies have not complied with their obligation to publish:

- (a) their Annual Financial Report for the year ended 31/12/2019,
- (b) their Half-Yearly Financial Report for the period ended 30/6/2020,
- (c) their Annual Financial Report for the year ended 31/12/2020,

- (d) their Half-Yearly Financial Report for the period ended 30/6/2021,
- (e) their Annual Financial Report for the year ended 31/12/2021,
- (f) their Half-Yearly Financial Report for the period ended 30/6/2022.

As a result, investors are not provided with all necessary information on the financial situation of these companies.

2. Cyprus Trading Corporation Plc, Ermes Department Stores Plc, Woolworth (Cyprus) Properties Plc

The above companies have not complied with their obligation to publish:

- (a) their Annual Financial Report for the year ended 31/12/2020,
- (b) their Half-Yearly Financial Report for the period ended 30/6/2021,
- (c) their Annual Financial Report for the year ended 31/12/2021,
- (d) their Half-Yearly Financial Report for the period ended 30/6/2022.

As a result, investors are not provided with all necessary information on the financial situation of these companies.
